CHIEF versus CDS:

CHIEF	CDS
Box 44 Document	D.E. 2/3 and 8/7
LIC99 waiver	LIC99 no longer permitted, commodity code specific document codes must be used, including waiver document codes where applicable
New codes used on CDS not yet set up on CHIEF	Codes live on CHIEF no longer used in CDS
Codes on CHIEF have different completion instructions from CDS	Details to be declared on CDS to be completed using Appendix 1, 2 and 5A instructions



Module 6: Document Codes and Waivers

What are document codes used for?

A document code, with a reference number or other details to be declared is used to provide:

- Authorisation decision numbers
- Licence reference numbers and quantities where required
- Preference certificates and quantities where required
- Veterinary or Health Certificates and quantities where required
- Invoices
- Other commercial documents, such as packing lists

Document codes that can be used with CDS are detailed in Appendix 5:

- Appendix 5A Union: Document Codes that start with a letter
- Appendix 5A National: Document Codes that start with a number
- Appendix 5B: Document Status Codes
- Appendix 5C: Document Licence Types (Import and Export)

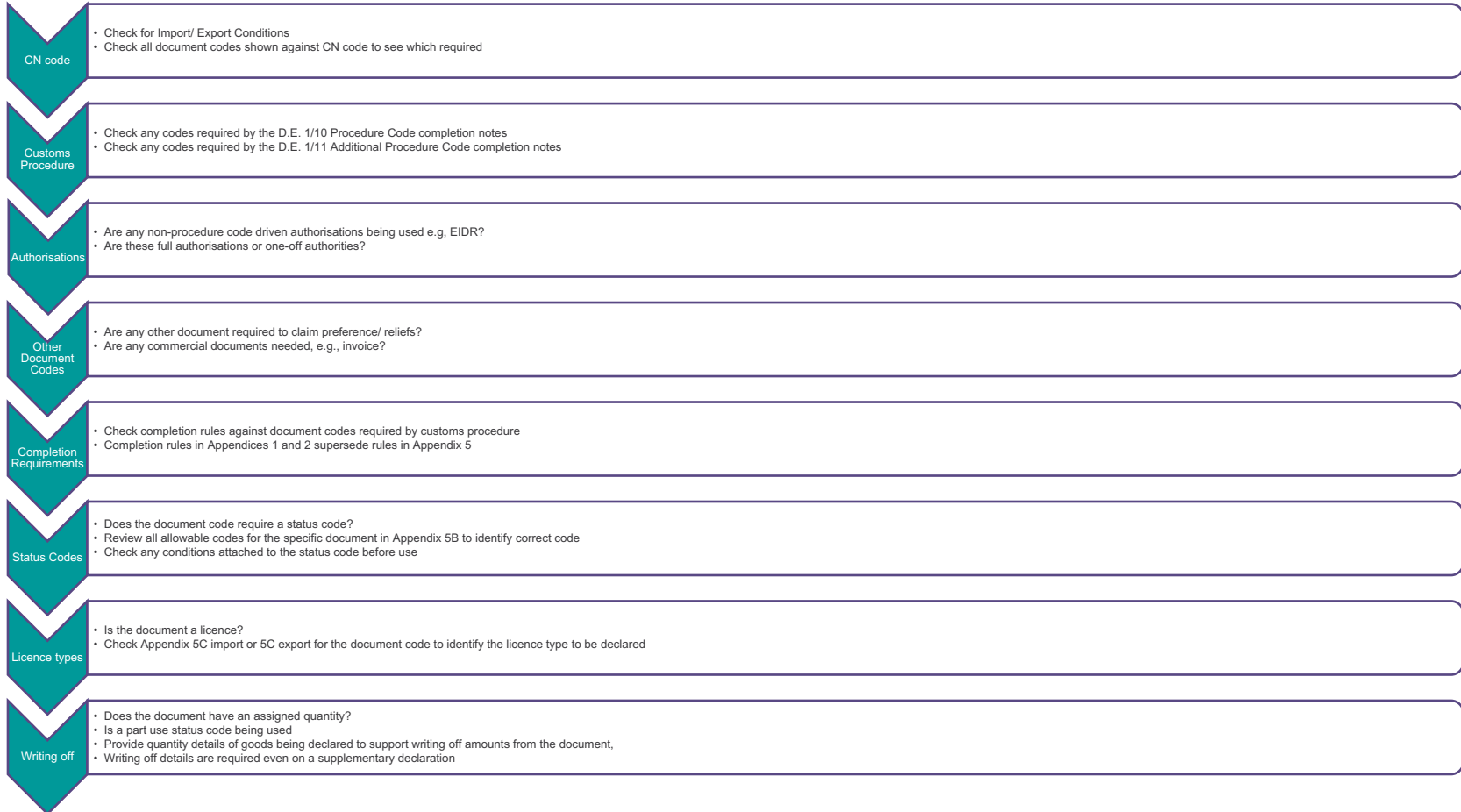

Module 6: Document Codes and Waivers

Commodity code:

- Look up the commodity code on Gov.UK (NI Tariff or UK Global Tariff (UKGT))
- Use the Import or Export Tabs depending on the type of movement being made
- Check any measures shown in the Import/ Export Controls sections
- Identify any general measures or measures specific to the country concerned
- Click on the 'Conditions' link to identify what documents are required for that measure.
- Where multiple measures apply, a document must be declared for each.
- Where allowed, the same document may be used to satisfy different measures.
- Look up the document codes shown in the measure in Appendix 5A to determine which code is the appropriate one to use

C844	Other certificates: Certificate of inspection for organic products	Import/export allowed after control
Y929	Particular provisions: Goods not concerned by Regulation (EC) No 834/2007 (organic products)	Import/export allowed after control
	No document provided	Import/export not allowed after control



Module 6: Document Codes and Waivers

Which Tariff Measures apply in Northern Ireland?

Status of the goods	Tariff Measures Applicable
UK Domestic Status and not 'at risk'	EU Tariff measures only
UK Domestic Status and 'at risk'	EU Tariff measures only
RoW imports/ non-UK domestic goods and not 'at risk'	EU Tariff measures and UK measures must be satisfied
RoW imports/ non-UK domestic goods and 'at risk'	EU Tariff measures only



Module 6: Document Codes and Waivers

Procedure Codes and Additional Procedure Codes:

- DE 1/10 and DE 1/11 completion notes (Appendices 1 and 2) may specify certain document codes
- The DE 1/10 and DE 1/11 completion notes will state whether they are mandatory or recommended
- The DE 1/10 and DE 1/11 completion notes are not an exhaustive list of every document code required for the customs procedure.
- The completion instructions for the document code may differ in the DE 1/10 completion notes than the main Appendix 5 guidance.
- The full list of document codes (Appendix 5) must be checked to identify if any extra codes apply.



Module 6: Document Codes and Waivers

Authorisations:

- Authorisation numbers are declared using a document code in DE 2/3.
- Any authorisation declared in DE 2/3 must also be entered in DE 3/39 to avoid validation errors
- Where a customs procedure is linked to a specific type of authorisation, the DE 1/10 completion notes will provide details of the document codes required for that type of authorisation.
- These authorisations may only be needed in certain circumstances, Appendix 1 will provide details.
- The authorisation is required to be declared at item level, where it relates to more than 1 item, it must be repeated on every goods item
- Appendix 1 only provides guidance on the authorisations that are linked to the specific procedure. Any other authorisations being used to declare the goods must be looked up in Appendix 5 separately, e.g., EIDR.



Module 6: Document Codes and Waivers

Other document codes:

Appendix 5A must be reviewed to identify any other document codes that are required in order to declare the goods, for example:

- Preference
- Quotas
- Commercial documentation: Packing lists, invoices



Module 6: Document Codes and Waivers

Completion rules:

- Appendix 5A provides general instructions on how the document code should be declared.
- Any completion instructions in Appendices 1 and 2 take precedence over those in Appendix 5A
- Appendix 5A must be checked to identify if there are specific rules for that document code on whether a Document ID or Reason is required.
- Waiver documents (C series) will generally require a Document ID, Reason and a waiver Status Code
- Waiver documents (Y series), do not generally require a Document ID or Status Code. Where 'set text' is specified on the document code, this must be declared in Reason.
- Generally status codes UA, UE, UP, US, XX or XW will require both a Document ID and Reason

Module 6: Document Codes and Waivers

Status Codes:

- Each document code will specify if a status code is required or not in Appendix 5A
- Where a status code is needed, the document code will identify which status codes may be used.
- If a status code is not shown against a given document code it cannot be used.
- Appendix 5B provides details of what each status code means
- Where Status codes UA, UE, UP, US, XX or XW are used, both a Document ID and Reason must be declared for the document code



Module 6: Document Codes and Waivers

Licences:

- Licence Type codes may differ between CHIEF and CDS, ensure the licence type as shown in Appendix 5C is used.
- Appendix 5C details to document codes where a Licence Type has to be declared
- These Licence Types are needed in addition to the licences actual reference number.
- Appendix 5A provides details of how the licence should be declared.
- Where a waiver document code (C series) is used, the Licence Type is still required.

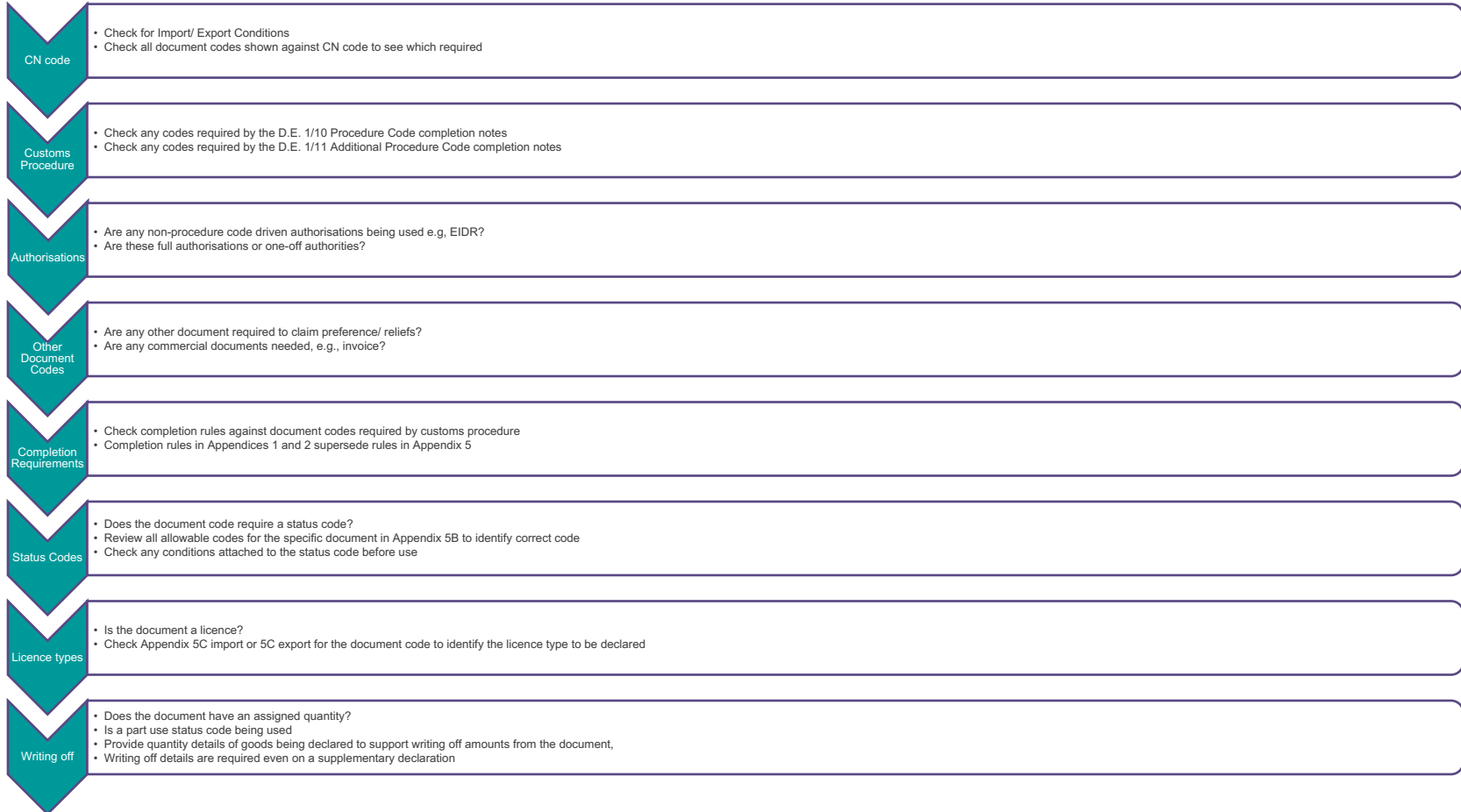
Writing Off:

- DIT and RPA licences always require writing off details
- Writing off details are only required for other licences when the goods are being released:
 - Where a licence is being part used
 - Imports: to a free circulation procedure where the licence details a specific quantity (H1, H5, I1 C&F and I1 B&E)
 - Exports: where the licence details a specific quantity (All Declaration Categories)
- Writing off details must be completed on both the controlled goods simplified declaration and supplementary declaration:
 - Simplified declaration: the amount actually being decremented from the licence
 - Supplementary declaration: a quantity of 0 plus appropriate Status Code should be declared to indicate that the amounts were decremented on the simplified declaration
