#### Movement of goods from GB to NI:

- Declaration walkthrough example: GB NI
- Release of UK domestic goods for free circulation in NI without payment of taxes
- Goods are not 'at risk'
- Grouping is used to combine multiple goods items under a single tariff heading
- Licences are waived under a temporary easement



#### Declaration walkthrough example: modules 2 - 7:

- Declaration date: 02/03/2020
- Goods arrived at Port of Tilbury on 1/3/2020
- Port/ Shed reference number: CNSTILEGK1-1247, 6<sup>th</sup> item removed from manifest
- Shed Operator: Allport Cargo Services Limited
- Shipped to Tilbury for collection by importer
- Agent completing declaration on behalf of importer
- Deferment account belongs to Agent
- Guarantee number: Not required post 1/1/21, qualify for exemption
- Transaction Ref: CDSTARIFFTRAIN-1
- 1,200 Girls Cotton T-Shirts in packs of 3, various colours and sizes
- Sold direct from US manufacturer to UK importer for \$1,750
- Goods to be released at the border after payment of all taxes and charges
- No declaration simplified procedures being used
- No reliefs or suspensions being claimed



#### How to complete a CDS declaration example: module 8:

- 1200 Leather Handbags, Cows Hide Handmade
- Shipped to Heathrow for collection by importer
- Goods arrived at Heathrow 31/09/2019 entered to British Airways Shed: CCS-UK123456
- Goods declared to CDS for entry to warehouse 01/10/2019 with no simplifications used
- Taxes to be paid on release from warehouse
- CFSP Authorisation number: GB123456789001
- Agent/ Warehousekeeper: GB211123456001
- Warehouse ID: R1234567GB
- Stock Reference: STK1248/101
- Unique commercial consignment ref for the removal: 3<sup>rd</sup> removal of day, ref: 1248/101
- Goods were entered to EIDR records on: 01/03/2020, 6<sup>th</sup> EIDR removal of the day
- Warehouse removal declaration data now being submitted to CDS on 23/3/2020
- CCG Guarantee number: 1246/20/20
- Transaction Ref: CDSTARIFFTRAIN-2A (entry to CW), CDSTARIFFTRAIN-2B (ex-CW)
- No reliefs or suspensions being claimed on removal from warehouse



#### Import of goods for processing:

- 100 Car Engines for Model: Noddy 1, 1100CC Hybrid
- Sold direct from Japanese manufacturer to UK importer
- Shipped to importer's premises for processing, via Lochaline, presented on 5/3/2020
- Valuation determined on entry to procedure
- Importer submitting their own declaration
- Authorisation number: 0927/126/22
- 0% guarantee waiver CCG reference: 1687/20
- Transaction reference: CDSTARIFFTRAIN-3
- Import safety and security declaration reference: 20GB123456789012T2
- No declaration simplified procedures being used
- Note: Following acceptance this declaration was given a CDS reference number of 20GB123456789101R1

#### Re-export of goods after processing:

- Cars manufactured from imported engines and UK chassis
- Exported to US after being processed
- Customs debt rules established at time of entry to procedure
- Entered to IP under scenario 3: 20GB123456789101R1
- Exporter is completing their own export declaration
- No declaration simplified procedures being used
- Exporter is authorised to place goods under customs supervision inland (Customs Supervised Exports): GB123456789001



Customs Clearance Request (CCR) Import: release at border after payment of taxes:

- Request for clearance of professional and laboratory equipment, temporarily exported to the US or use by a Dr, the goods having now returned to the UK.
- One item is re-imported by the Hospital, and the other by the Dr.
- Agent arranging clearance of the vehicle: GB101987654321
- Goods originally exported via a C21e on 1<sup>St</sup> Feb 2020.
- Transaction reference: CDSTARIFFTRAIN-5
- Port and Shed reference number: CCSUKLHRBAC1234.
- Goods in BA cargo shed at Heathrow.



Customs Clearance Request (CCR) Import: temporary import of goods:

- Private individual bringing in their Winnebago to use to tour the UK for 6months
- Agent arranging clearance of the vehicle: GB211123456001
- Transaction Reference: CDSTARIFFTRAIN-6
- Port and Shed reference number: CNSPTMAJQ-16320-6
- Goods due to arrive at Albert Quay, Portsmouth on 31/03/2020
- Note: Following acceptance this CCR was given a CDS reference number of 20GB123456789102R1



Customs Clearance Request (CCR) Export: re-export of goods after temporary admission:

- Private individual re-exporting their Winnebago after touring the UK for 6months
- Agent arranging clearance of the vehicle: GB211123456001
- Agent's Ref:AK6064
- Transaction Reference: CDSTARIFFTRAIN-7
- Port reference number: CNSPTMAJQ-30920-7
- Goods due to depart from Albert Quay, Portsmouth on 30/09/2020
